This agreement allows the above-named adopter to take home the above-named dog(s) on a temporary basis (no more than 10 days, without express permission by Doggie R & R representative) prior to completing the permanent adoption. Doggie R & R offers this trial period in good faith to assist the potential adopter in evaluating the suitability of this dog in his/her household and expects the temporary adopter to take responsibility for this dog as his/her own during this trial period.

I have completed the required Doggie R & R adoption application and have reviewed and agreed to all provisions of the Doggie R & R adoption contract.

If, within the 10-day period, I decide that this dog will fit appropriately into my household, I will contact a representative of Doggie R & R to finalize the adoption by signing the adoption contract and completing the adoption fee (deposit taken during trial).

If I decide not to complete the adoption, I will return the dog to Doggie R & R immediately to give it the opportunity to find a new home. Any deposits will be returned or refunded ASAP by Doggie R & R on return of the dog(s).

During this trial period, I am bound by all provisions of the adoption contract, but I will contact Doggie R & R before any veterinary treatments or examinations, except in a life threatening emergency when a representative of Doggie R & R cannot be reached. A Doggie R & R representative will be contacted ASAP and charges covered by Doggie R & R will be on case by case depending on if emergency. Any expenses incurred by me for the personal or veterinary care of this dog during the trial period will be my responsibility and are not reimbursable by Doggie R & R, and those costs are not credited toward payment of the permanent adoption fee.

I will keep a collar and identification on the dog and I am responsible for the dog's supervision. If, for any reason, the dog escapes my possession and is confiscated by animal control or another government

agency, I will notify Doggie R & R immediately and I am responsible for any costs and fines incurred in retrieving the dog.

The trial agreement may be terminated by either party at any time during the trial with the dog being surrendered back to Doggie R & R either by request of Doggie R & R or by potential adopter. The adoption fee may not be returned or refunded with termination during trial depending on situations based on Doggie R & R approval.
